- Beginning Wednesday, March 11, lecture courses (including discussion sections) and seminars will be offered through alternative modalities (e.g., Zoom) to reduce face-to-face interactions as much as possible.
- In-person winter quarter final exams will be conducted via alternate means not in person. Instructors will be communicating with their students this week about alternative plans for assessment on a course-by-course basis.
- If a student is not able to complete the option(s) provided by the instructor, the student may be given an incomplete (I) at the student's request if their work was of passing quality but incomplete. Instructors should be clear as to what needs to be done within the next quarter to remove the incomplete

- 1. The exam will be open notes (and open class WWW site) but no other books or 'searches' and **CERTAINLY NO COLLABORATION WITH ANYONE ELSE.**
- 2. The exam can only be done between 4:00PM-7:00PM on 19<sup>th</sup> March (remotely or on-campus computer links). It should NOT take you anywhere near the allotted 3 hours. I will consult DRC on how to extend time for those students who take the exam with DRC.
- 3. The exam will have 'problems' on material similar to HW#7 and HW#8 and other types of questions to cover conceptual material from throughout the quarter.
- 4. However, by the nature of an on-line exam, the responses will be limited to entering numbers (results of problems) and various types of 'objective' question formats.
- 5. During the exam, I will be available by e-mail (and can respond to the whole class by CANVAS announcement).
- 6. On the CANVAS final you will be asked to indicate that the work you are submitting is your own, and not done by interacting with another
